2019 Landmark Supreme Horse Sale Toowoomba

Landmark Operations Limited (ACN 008 743 217) Terms and Conditions

1. The standard Australian Livestock & Property Agents Association Ltd (ALPA) terms and conditions for livestock sale apply to livestock sales made at the Landmark Supreme Horse Sale. A copy of the ALPA terms and conditions will be available at the Toowoomba branch of Landmark and at the Landmark Supreme Horse Sale.
2. All horses offered for sale at the Landmark Supreme Horse Sale must be either a registered Australian Stock Horse or a registered Australian Quarter Horse or registered with the Equine Performance Registry of Australia. ASB (Breeding purposes only) broodmares are eligible for the sale provided they are accompanied with a current veterinary pregnancy test certificate, dated not more than 45 days prior to the sale. **Pregnancy Test Certificates must be sent to the Landmark Toowoomba Branch prior to sale.** No foal recorded horses will be accepted. Any horses accepted as a colt cannot be sold as a gelding. Horses must be registered prior to nominating for sale. If the horse's registration has not been finalised by the close of nominations, the selling agents cannot accept the entry form.
3. Original registration papers and signed transfers are required when presenting horses for inspection. Nominations will not be accepted unless accompanied by the entry fee (Ridden Horses \$440 inc GST per horse, Yearlings & Broodmares \$385 inc GST per horse). Nomination forms without a vendors signature cannot be accepted. Nominations will close on Friday, 15th February 2019. A copy of the horse's registration papers must accompany the nomination form.
4. Any horse sold at a Landmark Supreme Horse Sale that is then sold on by any means other than at a Landmark Supreme Horse Sale will not be eligible to compete in a Landmark Challenge.
5. The owner is responsible for checking that the information on the horse's registration certificate is correct at the time of nomination, i.e. sex, colour, brands, markings etc. Owners are advised to review the relevant Society's (i.e. Australian Quarter Horse Association (AQHA) or Australian Stock Horse Society (ASHS)) regulations relating to Horse Identification obtainable from the relevant Society, in particular the verification of brands and markings policies. A horse would be rejected from the Landmark Supreme Horse Sale under the relevant identification Regulations which AQHA & ASHS carry due to brand or significant marking discrepancy. Horses must be presented to the satisfaction of an appointed Landmark Supreme Horse Sale Inspector and may be vet checked prior to sale commencement. The inspectors may reject a horse from the sale if the horse does not comply with the following conditions:
 - a) Markings and brands described on the horse's registration papers **MUST** be clearly visible and identical to the horse presented at inspection;
 - b) The horse should be presented suitably for the sale; and
 - c) The horse should be free of undesirable characteristics and conformation faults (as per AQHA & ASHS Regulations (obtainable from the relevant Society)) eg. weaver, windsuckers etc.
 - d) Landmark reserves the right to reject any horse that they do not believe suitable for the sale.
 - e) If after taking into account market conditions, Landmark is of the opinion that too many animals have been nominated, vendors will be invited to review their entries.
6. Where the vendor has retained semen or embryos, this fact must be disclosed by the vendor to the Auctioneer prior to the sale of the lot. The Auctioneer will disclose these facts at the time of sale.
7. Commission of 7% will be payable to Landmark in respect of each lots catalogued and sold. This applies from the day catalogued to 10 days after the advertised Sale date, whether sold at Auction or private treaty. All accepted nominations must be presented through the Sale ring.
8. Any person involved with handling the horse on the day of the sale, within the perimeter of the grounds: i.e. strapper, handler, trainer, rider and the like does so at their own risk. An equestrian helmet approved by the Australian Standard Association or international equivalent with a chin strap securely fastened **MUST** be worn by all riders/competitors under 18 years of age when riding within the perimeter of the grounds, not just in the ring.
9. The Sale Committee reserves the right to restrict sale entries pending venue conditions.
10. Landmark does not accept any liability for any accident, damage, injury to horses, riders, beasts, ground spectators, or any other person or property. Handling or riding of horses during or after the 2019 Landmark Supreme Horse Sale is undertaken at the owner and/or rider's own risk.
11. Landmark does not guarantee that cattle will be available on the day due to unforeseen circumstances or force majeure (force of nature) eg. flood.
12. Horses sold at a previous Landmark Supreme Horse Sale that are 36 months and under on the date of the Landmark Challenge the following year will become eligible to compete in the Landmark Challenge, to be held annually, unless they are a past winner of the Landmark Challenge.
13. Yearlings offered at the Sale must be born after August 1st, 2017.
14. To be eligible for entry as a broodmare at the time of the Sale, the mare **must** be in foal, **or** have a foal at foot less than 12 months of age.
15. Mares in foal must be pregnancy tested and a Veterinary Certificate produced, together with the relevant Breed Society form containing service details. The Veterinary Certificate must show the mare had been pregnancy tested within the 45 days prior to the 2019 Sale.
16. Broodmares with a foal at foot (foal must be less than 12 months of age) must produce a Certificate of Registration or Foal Recording Certificate with the relevant Society.
17. All broodmares must be 15 years of age or under as at August 1st, 2018.
18. ALL FOALS MUST BE LED.
19. NO WEANLINGS.
20. No horse will be accepted without Waybill, Permit or both being placed in the hands of inspectors.
21. No supplementary lots allowed following completion of the draw.
22. No uncataloged horse will be allowed to be offered for private sale, or advertised for private sale, in or around the Sale arena.
23. Ridden entries must be aged between 2 years and 15 years as at May 1st, 2019. No PTIF mares will be sold in the ridden section.
24. Landmark reserves the right to accept horses outside these Terms and Conditions.
